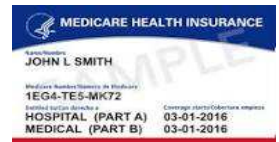

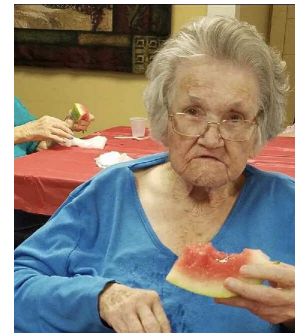
## Activities in July
