

COVID-19 UPDATE


As of 5/29/20, we have had 15 employees test positive, 12 recovered and 3 active. We have had 14 residents positive, 12 recovered, 2 deaths and 0 active! Since we have NO active resident cases in the facility all halls are back open, and residents can go out of their rooms if they wear a mask and are kept six feet apart. We are still not allowed to let any visitors in the facility. Please know that we want our residents to be able to visit with their families as much as you do but, the CDC recommendations are to still not allow visitors.
